**"Reg D" Excessive Transaction Fee\*.....\$10/transaction**

*\*Regulation D governs the amount of transactions that can take place on a savings account. Savings accounts are permitted six (6) transactions per month. Any transaction in excess of six (6) during a calendar month is assessed the "Reg D" Excessive Transaction Fee.*
